MINUTES

- 1. Call to Order/Pledge of Allegiance; Chairman Anderson called the meeting to order at 7:25 pm, and the pledge of allegiance was said.
- 2. Roll Call: Also present were Supervisors Ginter and Vollmar.
- 3. Public Comment: Curt Haga appeared to compliment the board on the new collection site attendant and the new provider, he mentioned that the compactor is an improvement as well.
- 4. Public Appearance: none
- 5. Approval of Clerk's Minutes from June 20, 2018: Supervisor Ginter made a motion to approve the Clerk's minutes from 6/20/18, Supervisor Vollmar second, motion carried.
- 6. Approve Treasurer's Report for June 30, 2018: Supervisor Ginter made a motion to approve the Treasurer's report dated 6/30/18, Supervisor Vollmar second, motion carried.
- 7. Reports from Town Officials: Chairman Anderson informed the board that the Town received the broadband grant for \$10,000 from the Forest County Potawatomi Community, and the State broadband grant has been applied for. We are working with Northwoods Connect for the grant application, they are a wireless provider in the northwoods. The grant amount applied for is \$109,000 and the matching amount will be contributed in several ways, some of them being town property for the tower, town equipment and labor for site prep, the grant from FCPC, and possibly a small cash contribution fom the town if approved.

- c. Painting North Town Buildings: the building have been painted, and we are working on a new sign for the front of the building.
- d. Cemetery Survey; Chairman Anderson met with the Pitt's and hopes to have the survey recorded by the next monthly meeting.
- e. Resolution form WTA regarding roads: Supervisor Vollmar made a motion to approve resolution 2018-4 presented to the town by the Wisconsin Towns Association, Supervisor Ginter second, motion carried.
- f. Resolution to discontinue Short Lane: No Action
- g. Mole Lake Boat Landing
 - i. Tree Clearing: Clearing complete, trees still on site.
 - ii. Stump Grinding: stumps are ground and will be removed soon.
 - h. Cemetery Work
 - i. Landscaping: landscape work will be deferred to the Cemetery Committee.
- i. Employee Retirement transition: Interviews are being held on Monday, July 23, 2018.
- j. Cleaning of Road Right-of-Ways: Chairman Anderson met with the Town of Crandon, they are in agreement to allow the Town of Nashville to clear the right-of-way on Rocky Siding Lane and share the expense.
