

## **Town of Nashville Meeting Agenda**

**Date:** October 14, 2025, **Time:** 5:00p.m.

**Location:** Nashville Town Hall, 4265 Sate Hwy 55, Crandon

1. Call to Order, Pledge of Allegiance: Chair Torgerson called the meeting to order, and the pledge of alliance was said. She noted that the meeting was properly noticed and then amended the agenda to add item 7e, transfer of funds.
2. Roll Call: Also present was Supervisors Palubicki, Maes and Clerk/Treasurer Frank. Others totaled 4
3. Approval of Previous Meeting Minutes; Review and approve minutes from Sept 9, 2025 Regular Meeting, and September 11, 2025, special meeting: motion by Maes, seconded by Palubicki to approve the minutes from September 9 and September 11 meetings. All in favor, motion carried.
4. Treasurer's Report for September 2025, outstanding claims to ck #6736 and September Auto withdrawals: Motion by Palubicki, second by Maes to approve the September Treasurers report, outstanding Claims to Ck #6736 and September auto withdrawals. All in favor, motion carried.
5. Public Comment: Rose Chaney appeared to inquire about the possibility of renting the hall for a craft event. (see below correspondence for board action)
6. Reports from Officials: Culverts: Jungle Lake and Arbutus/Grass Lake, Tower Rd: Chair Torgerson reported that culverts have been installed on Jungle Lake, Arbutus Grass Lake and Tower Roads. Jungle and Arbutus/Grass Lake culverts were installed per DNR permitting and guidance.
7. Action Items
  - a) Porta Potty's at collection sites: Motion by Maes, Second by Palubicki to approve the purchase of two used Porta Pottys for \$600.00 from Randys Septic service. All in favor, motion carried.
  - b) Cameras at boat landings: Tabled
  - c.) Cell Tower on Stautner Rd: Motion by Palubicki, second by Maes, to amend the lease agreement to reflect the following: \$30,000.00 down payment, \$800 per month/20 years and increase of 2.5% per year. All in favor, motion carried
  - d.) ROW permit application and fee: Motion by Palubicki, second by Maes to approve the new permit application form and a fee of \$25.00 per drop or \$300.00 per road. All in favor, motion carried.
  - e.) Transfer funds from Escrow account to checking (parking lot and capital purchase): Motion by Maes, second by Palubicki to approve the following:  
Motion 1: Transfer of \$169.91 from the FCPC Festival Booth Reserve account to the Checking account and \$4000.00 from the Sokaogon Chippewa Grant Reserve

account to the Checking account to pay for the Parking Lot extension. All in favor, motion carried.

Motion 2: Transfer \$20,000.00 from the 2025 Capital Purchase reserve budget line account to the Capital Purchase Reserve Account. All in favor, motion carried.

9. Correspondence & Any Additional Action Items: Torgerson reported on the Pickerel and Crandon Rescue squads (proposed) increases for the next 2 years, it will be addressed at a future meeting. She read the website stats and inquired who will be attending the WTA meeting next week.

Motion by Palubicki, seconded by Maes, to approve the rental of the Town Hall to Rose Chaney for \$200.00 for a craft fair on November 30<sup>th</sup>, with any electric used to be an additional fee. All in favor, motion carried.
