MINUTES

1. Call to Order, Pledge of Allegiance: Chair Torgerson called the meeting to order and noted that the meeting was properly posted. (pledge was not said because it was said at the annual meeting). Chair Torgerson amended the Agenda to remove action items 7.b and 7.d.
2. Roll Call: Others present included Supervisors Palubicki, Maes and Clerk/Treasurer Frank. Others present totaled 4.
3. Approval of Previous Meeting Minutes; Review and approve minutes from March 10, 2026, meeting.
4. Treasurer’s Report for March 2026, outstanding claims to ck #6820 and April Auto withdrawals and online Bill Payments: Motion by Maes, second by Palubicki to approve the March Treasurers report outstanding claims to ck 6820 and April auto withdrawals and online bill payments. Seconded by Palubicki, all in favor, motion carried.

6. Reports from Officials: Chair Torgerson reported she signed the paperwork for the new plow truck and that Quinlan’s will order it right away.

 - a) Truck bid Award: Motion by Maes, second by Palubicki to approve the International truck (Cummins engine), to be ordered from Quinlan’s at a total cost of \$120,011.082 and the truck upfitting from Phoenix Bodyworx upfitting in the amount of approximately \$148,466.00. Motion was seconded by Torgerson, all in favor of motion carried.
 - b) Elected officials’ salaries: Supervisors -item removed as amended per town chair
 - c) Dumpsters: Motion by Palubicki to approve notifying businesses that they must purchase dumpsters and will no longer be allowed to use the recycling center for garbage and recycling beginning on 7/1/2026. (NOTE: per the county recycling program grant provisions, only for 1 & 2 family dwellings are an allowable cost. Businesses are encouraged to contact Forest Co Zoning with any questions.)
 - d) Cost Sharing Agreement with Lily Lake District: item removed as amended per town chair
